

## CHECKLIST FOR SIGN PERMIT APPLICATION

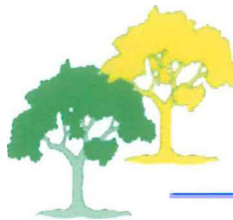

Pursuant to Chapter 405 of the Unified Development Code any person, firm, corporation or organization desiring to place, erect, alter or relocate a sign, as herein defined, except an exempt sign, shall make application to the Building Inspector and shall provide in writing the following information:

- \_\_\_\_\_ 1. Application with name, address and telephone number of the applicant, owner (or owner's authorized representative) and the person, firm, corporation or association erecting the sign.
- \_\_\_\_\_ 2. Include linear footage of road frontage and square footage of all existing signs on the building.
- \_\_\_\_\_ 3. Attach plot plan, dimensioned, showing the location of the building, structure and lot that the proposed sign is to be attached to or erected on.
- \_\_\_\_\_ 4. Attach photographs showing the location of the proposed sign and its relationship to the building that it is to be mounted on or the surrounding area if it is not a wall sign.
- \_\_\_\_\_ 5. Attach one (1) drawing of the proposed sign showing the message to be displayed and method of construction, landscaping and attachment to the building or ground.
- \_\_\_\_\_ 6. Attach colored sketch showing the proposed color combination of the sign with the proposed and existing surrounding materials.
- \_\_\_\_\_ 7. Attach written consent of the owner (or the authority to act on behalf of such owner) of the building, structure and land that the sign is to be erected on with the Ownership Affidavit included with the application.
- \_\_\_\_\_ 8. Attach description of all electrical equipment and attachments if the sign is to be lighted by a secondary light source or an illuminated sign. This will require a separate electrical permit.
- \_\_\_\_\_ 9. Attach a picture of existing face and a picture of proposed new face for face replacement.

All permanent signs shall be designed and constructed using a licensed and bonded sign company. All permanent signs shall use appropriate materials and shall not be constructed using the following materials: wood; lightweight cloth or canvas, except approved canopies or awnings; paper; cardboard; or any other material that has not been approved by the City for construction of a permanent sign. I hereby confirm that the information submitted on this document and application is true and accurate.
